Arena – Chris Dolan

There were a couple Black Hawks games this past weekend and attendance is ramping up as it usually does when we get into the winter season. High School team had their opener the previous weekend and won against Des Moines. The Munters unit is now working well after several meetings and several trips from the rep from Omaha working on the unit – especially the heat. A couple upcoming wrestling events Dec. 5 & 6 and Battle of Waterloo Wrestling Tournament Dec. 19, 20 and 21.

Sports and SportsPlex – Mark Gallagher

Sports is busy with youth leagues and adult leagues. SportsPlex membership stands as 1393 units. KWWL marketing ads will begin in December. Twenty-two additional club locker rooms have been ordered due to being completely sold out. Contractor will treat floors in the area of family locker room and back hallway. Looking at matting on the weight floor area. This week rails will be placed on the back of bleacher pads on both sides. Kilo Trained is now paying rent. Cedar Valley Youth Soccer Assoc. will be renting late Nov. through March from 6:30-10:30 PM. Also working with a group of guys who want to play soccer to have the building open after that coming in at 10:00 PM. Looked into the news reports and concerns about the turf and potential carcinogens. The rep at Anderson Lab has told us there are virtually zero concerns about the turf. All restrooms that were covered were hail damaged back in 2012. Boat docks are out. All the water systems are shut down. Miscellaneous repairs and preparing for winter.

Port-a-potties were installed at the courses after the main restrooms were closed for the season. Irv Warren finished installing tile line.
