AN ORDINANCE ADOPTING THE 2020 TRAFFIC CODE OF ORDINANCES OF THE CITY OF WATERLOO, IOWA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WATERLOO, IOWA AS FOLLOWS:

- SECTION 1. Pursuant to published notice and following public hearing on the 21st day of September 2020, so required by Sections 362.3 and 380.8, Code of Iowa, there is hereby adopted by the City of Waterloo, Iowa, the "Traffic Code of Ordinances of The City of Waterloo, Iowa."
- Section 2. This ordinance shall only apply to the "Traffic Code of Ordinances of the City of Waterloo, Iowa".
- SECTION 3. All of the provisions of the "Traffic Code of Ordinances of The City of Waterloo, Iowa," shall be in force and effect on and after the effective date of this ordinance.
- SECTION 4. All ordinances or parts thereof pertaining specifically to the Traffic Code of Ordinances of the City of Waterloo, Iowa, in force on the effective date of this ordinance are hereby repealed from and after the effective date of this ordinance.
- SECTION 5. The repeal provided for in the preceding section of this ordinance shall not affect any offense or act committed or done or any penalty or forfeiture incurred before the effective date of this ordinance; nor shall such repeal affect any ordinance or resolution promising or guaranteeing the payment of money by the City or authorizing the issuance of any bonds of said City or any evidence of said City's indebtedness; nor shall it affect any other right or franchise conferred by any ordinance or resolution of the Council or any other person or corporation; nor shall it affect any ordinance naming, establishing, relocating or vacating any street or public way, whether temporary or permanent; nor shall it affect any ordinance amending the official zoning map, establishing building lines, establishing and changing grades, or dedicating property for public use; nor shall it affect any prosecution, suit or other proceeding pending or any judgment rendered on or prior to the effective date of this ordinance.
- SECTION 6. An official copy of the "Traffic Code of Ordinances of The City of Waterloo, Iowa," adopted by this ordinance, including a certificate of the City Clerk as to its adoption and the effective date, is on file in the office of the City Clerk, and shall be kept available for public
